The Company adopted a Pre-IPO share option scheme on 13 November 2014 and the share options originally granted by CK Telecom (Great China) Inc., a direct wholly-owned subsidiary of the Company, were exchanged into the Pre-IPO share options. Accordingly, options comprising 59,935,000 underlying shares at an exercise price of RMB 0.4 per share have been granted to certain eligible participants. Due to the turnovers of employees, options comprising 3,235,000 underlying shares lapsed.
