(1) The ordinary shares with par value of HK\$0.01 each in the share capital of the Company (the “Shares”) were initially listed on the Main Board of The Stock Exchange of Hong Kong Limited on 2 December 2014.

(2) The Company adopted a Pre-IPO share option scheme on 13 November 2014 and the share options originally granted by CK Telecom (Great China) Inc., a direct wholly-owned subsidiary of the Company, were exchanged into the Pre-IPO share options. Accordingly, options comprising 59,935,000 shares at an exercise price of RMB 0.4 per share have been granted to certain eligible participants.

(3) The stabilising period in connection with stabilising actions ended on 25 December 2014 and the over-allotment options lapsed on the same date. For details, please refer to the Company’s announcement and prospectus dated 29 December 2014 and 20 November 2014, respectively.
