**INCREASE IN SHAREHOLDING BY THE CONTROLLING SHAREHOLDER**

This announcement is made by Q Technology (Group) Company Limited (the “**Company**”) on a voluntary basis to update its shareholders and potential investors in relation to the increase in shareholding by the Company’s controlling shareholder, Mr. He Ningning (“**Mr. He**”), an executive director of the Company and the chairman of the board of directors of the Company (the “**Board**”).

The Company has been informed by Mr. He that on 28 December 2018, he acquired a total of 592,000 ordinary shares of the Company (the “**Shares**”) through Q Technology Investment Inc. (“**QT Investment**”), which is wholly owned by Mr. He, through on-market purchase at the total consideration of approximately HK\$2,597,000 with an average price of approximately HK\$4.39 per Share. The said 592,000 Shares represent approximately 0.05% of the total issued share capital of the Company as at the date of this announcement.

Immediately after the completion of the abovementioned purchase, QT Investment was interested in a total number of 752,191,000 Shares, representing approximately 66.46% of the total issued share capital of the Company as at the date of this announcement.
